INTRODUCTION

This pamphlet is one of a series of reports describing the geology and water resources of Yankton County. It is designed to be an uncomplicated, non-technical aid in the search for sand and gravel deposits.

Other reports in the series include:

- a. Major aquifers in Yankton County, South Dakota: South Dakota Geological Survey Information Pamphlet no. 28, Bugliosi, Edward F., U.S. Geological Survey, 1983.

Report (a.) describes the availability, quality, and location of major aquifers (water-bearing deposits) in a short, easy to read, pamphlet. Report (b.) is a more technical and somewhat more exhaustive investigation of the water resources of the County. Report (c.) is a scientific investigation of the geology of Yankton County.

GEOLOGIC OVERVIEW

Most of the sand and gravel deposits found in Yankton County were deposited by glacial ice or meltwater that covered the region thousands of years ago. Some sand and gravel has been deposited by streams since the retreat of the glaciers. A short description of geologic terms used in this text follows.

Glacial Till

The glaciers were large masses of ice that thousands of years ago, originated from snow accumulations to the north. These glaciers flowed southward to the area that is now Yankton County, picking up earth debris as they went. Some of this debris, a mixture of clay, silt, sand, gravel, and boulders was redeposited directly from the ice. Till, the term used to describe this mixture, is also often called "blue clay" or "boulder clay." In the Yankton County area the till is made up primarily of clay and is not considered a source of sand and gravel. However, small isolated sand and gravel hills or lenses may occur.

Glacial Outwash

Glacial outwash is the term used to describe any deposit of glacial debris which has been washed and sorted by water flowing from melting glacier ice. The grain size of these deposits depends upon the velocity of the water which deposited them and upon the type of material. Deposits left by slow flowing streams are made up primarily of silts and clays. Very fast flowing streams may have left streambeds composed entirely of boulders. Most glacial outwash, however, is made up of an assortment of sand and gravel, with minor amounts of finer and coarser materials. Deposits of glacial outwash are a major source of sand and gravel in Yankton County.

Alluvium

Alluvium is the term used to describe the material deposited by streams since the retreat of the glaciers. Grain size of the alluvial deposits is determined by the same factors as glacial outwash. Alluvium is found in the valleys of present-day streams and can often be a good source of sand and gravel.

Terrace Deposits

Terrace deposits are flat-topped alluvial or outwash deposits that are remnants of former flood plains. The streams which made them have since cut their channels deeper and developed new flood plains at lower levels. Some of the sand and gravel found in Yankton County occurs in this type of deposit.

Western Sand

Western Sand is an informal term used to describe sand and gravel deposited by non-glacial streams other than the present-day streams. Because these deposits are derived from non-glacial sources, they contain less silt and clay, and are well-sorted when compared to other aggregate sources in Yankton County.

Bedrock

Bedrock refers to the consolidated rocks underlying the glacial deposits. In Yankton County the bedrock consists primarily of shales and chalk. Bedrock crops out along the Missouri River and along several other creeks in Yankton County. No sand or gravel exists below bedrock found at the surface or encountered in test holes.

EXPLANATION OF TABLES

Table 1 is a list of only those test holes in which sand or gravel was encountered within 25 feet of the land surface. This table gives the locations of the test holes, and the depths and descriptions of the sand and gravel deposits. The complete logs of all the test holes drilled in Yankton County are on file at the South Dakota Geological Survey in Vermillion, South Dakota.

Table 2 is a list of sand and gravel pits on file with the South Dakota Department of Transportation, Division of Highways in Pierre, South Dakota. Where possible, this table gives the landowner, location, thickness of overburden, thickness of sand and gravel being mined, and type of aggregate deposit for each pit. The actual thickness of a deposit may be greater than that which is listed in the table as being mined.

EXPLANATION OF MAP

The map shows the location of the test holes and sand and gravel pits. It also shows the towns, major highways, and major lakes, rivers, and creeks.

Test-hole data are shown on the map using three types of map symbols. A dot (●) represents a test hole in which sand or gravel was found within 25 feet of the land surface, with 0 to 5 feet of overburden. A square (■) indicates that sand or gravel was found within 25 feet of the land surface but greater than 5 feet of overburden was encountered. These two types of symbols are numbered and the pertinent test-hole information is listed in table 1. The third symbol is an open circle (○), which indicates that no sand or gravel was found within 25 feet of the land surface. Logs of these test holes are available at the South Dakota Geological Survey in Vermillion, South Dakota. Locations of the sand and gravel pits are indicated by a crossed pick and shovel (☒). The pits which are numbered are listed in table 2, and additional information is on file at the Department of Transportation, Division of Highways, in Pierre, South Dakota. No attempt was made to distinguish the inactive pits from the actively mined pits.

To aid in the delineation of the most promising areas of finding sand and gravel, the map has been divided into three area types, "good," "fair," and "poor." These three types of areas were differentiated using test-hole data, sand and gravel pit locations, soil survey information, topographic map and aerial photograph interpretation, and field observations. Areas with a "good" or "fair" probability of finding sand and gravel have been assigned a letter on the map and are discussed further in the following section.

Sand and gravel deposits found in the "good" areas are generally thick, have very little overburden, and cover a broad area. In these areas, much mining for sand and gravel has already

occurred and is occurring at the present time. Sand and gravel deposits found in the "fair" areas are generally thinner, have more overburden, or are laterally discontinuous. There are sand and gravel deposits in the "poor" areas, but a very expensive and exhaustive exploration program would be needed to locate all of these deposits.

Sand and Gravel

The areas, marked "A," consist of outwash and alluvial deposits located within the James River valley. Although a large number of "good" portions are found within these areas, they have been designated as "fair" because of their lack of lateral and vertical continuity. Much of the sand and gravel has been removed and replaced by silty alluvium, due to erosion by the James River.

Area "B," designated as "good," located in the northwest part of the County, is associated with a large highland known as the James Ridge. The deposits contain up to several hundred feet of poorly sorted sands and gravels, which are not laterally continuous over the entire area. The thickness of overburden is highly variable over the area, but averages about 5 feet for all test holes drilled.

Area "C," designated as "fair," contains remnant terrace deposits within the Mud Creek valley. The deposits of sand and gravel found there are thin and discontinuous.

Area "D," designated as "fair," consists of outwash and alluvial deposits located within the Turkey Creek valley. The sand and gravel is found in remnant terrace deposits along the valley walls and in isolated patches along the valley floor.

Area "E," designated as "fair," contains significant quantities of western sand. The deposits are discontinuous due to post-depositional erosion. Much sand and gravel has been mined from this area.

Area "F," designated as "good," consists of sand and gravel deposits found within the downstream portion of the Turkey Creek valley. Thick and continuous terrace deposits are found along the valley walls. Much mining for sand and gravel has occurred within this area.

Area "G," is located on the flood plain of the Missouri River. It has been designated as "fair" because the sand found there is very fine and contains much silt and clay. Large amounts of silty, alluvial overburden cover any good deposits of sand and gravel.

Area "H," designated as "fair," contains discontinuous remnant terrace deposits along the walls of the Marne Creek valley.

Area "I," designated as "good," contains thick deposits of sand and gravel within the James River valley. This portion of the James River valley differs from the portions marked "A" in that there is very little overburden and less erosion by the James River has occurred.

The areas marked "J" and "K" contain outwash deposits within the valley of Beaver Creek. Sand and gravel deposits found in the areas marked "J" are discontinuous due to post-depositional erosion. Sand and gravel deposits found in the areas marked "K" are thick and continuous. Much mining for sand and gravel has occurred and is occurring in the areas marked "K."

Area "L," is a small body of outwash located just east of Lesterville. It has been designated as "fair," because of the large amounts of overburden covering much of the area.

Area "M," designated as "good," is a small isolated deposit of sand and gravel located on a hilltop just north of Yankton.

Area "N," designated as "fair," and located in the southwest part of the County, contains scattered deposits of western sand, named the Bon Homme Gravel. Test holes, gravel pits and outcrops reveal material ranging from medium sand to medium gravel. Test holes drilled in Area "N" encountered up to 36 feet of western sand but the deposits are discontinuous due to post-depositional erosion.

ECONOMIC CONSIDERATIONS

It should be emphasized that this study is quite general and should be used only as a guide to further exploration and development of the sand and gravel resources. The development of a specific site will depend upon material specifications for the desired use, development costs, transportation costs, and future markets.


